Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Material Handling	Manual handling injuries, Falling objects	3H	<ul style="list-style-type: none"> - Use mechanical aids for lifting heavy materials. - Train workers in correct manual handling techniques. - Ensure materials are securely stacked and placed. - Conduct regular inspections of material storage areas. - Implement exclusion zones around lifting operations. - Use appropriate personal protective equipment (PPE) such as gloves and helmets. - Plan lifts to avoid manual handling where possible. - Supervise all material handling activities by experienced personnel. - Secure loads before transporting materials. - Use spotters when moving large materials through difficult areas. 	2M
3. Measurements and Marking	Inaccurate measurements, Tripping hazards	2M	<ul style="list-style-type: none"> - Use calibrated measuring tools for accuracy. - Double-check measurements with a second worker if possible. - Mark work areas clearly to avoid markings being obscured. - Keep the work area tidy and clear of unnecessary items. - Ensure good lighting conditions to improve visibility. - Train workers in precise measurement techniques. - Conduct on-the-spot checks to verify accuracy periodically. - Use floor tape or barriers to mark off the measuring area. 	1L
