### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	slips, trips and falls, chemical exposure	3H	<ul style="list-style-type: none"> <li>- Ensure all personnel have PPE including gloves, masks, and goggles and confirm its proper use.</li> <li>- Conduct a site inspection to identify any tripping hazards and clear them before starting work.</li> <li>- Review the Safety Data Sheets (SDS) for chemicals to be used.</li> <li>- Ensure good ventilation in the work area, and ensure it is well-lit.</li> <li>- Provide induction training for workers on site-specific hazards.</li> <li>- Use non-slip mats where necessary.</li> <li>- Maintain effective communication among team members regarding potential hazards.</li> <li>- Ensure appropriate waste disposal systems are in place.</li> <li>- Mark hazardous areas with visible signage.</li> <li>- Use chemical-resistant trays to contain any spills.</li> </ul>	2M

Surface Cleaning	chemical burns, inhalation	3H	<ul style="list-style-type: none"> <li>- Use only approved cleaning agents as per SDS.</li> <li>- Ensure workers wear long sleeves and pants to reduce skin exposure.</li> <li>- Implement dust suppression methods such as wetting surfaces.</li> <li>- Train workers on spill response procedures for cleaning agents.</li> <li>- Provide respirators with appropriate filters to mitigate inhalation risks.</li> <li>- Restrict area access to authorised personnel only during cleaning.</li> <li>- Keep emergency eye wash stations and showers nearby.</li> <li>- Use tools with extended handles to minimise contact.</li> <li>- Proper disposal of cleaning rags and containers.</li> <li>- Continually monitor air quality during cleaning.</li> </ul>	2M
