Notes on Hierarchy of Controls:
Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Identification	Misidentifying ACM, Cross-contamination	4A	<ul style="list-style-type: none"> - Utilize experienced professionals to visually inspect suspected ACM. - Collect samples of suspected materials for laboratory analysis. - Use high efficiency particulate air (HEPA) filtration vacuums during sample handling. - Clearly label and mark all identified ACM. - Take photographs of suspected ACM areas for documentation. - Use wet methods to suppress dust during sampling. - Ensure samples are sealed and transported according to regulations. - Document all findings in an Asbestos Register. - Maintain communication with laboratory to expedite sample results. - Train workers on distinguishing ACM from non-ACM areas. 	2M
