### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Inadequate footwear, Lack of awareness	3H	<ul style="list-style-type: none"> <li>- Conduct a briefing session for workers on the importance of proper footwear.</li> <li>- Ensure all employees receive updated training on situational awareness while using stairs.</li> <li>- Install appropriate signage reminding workers to be cautious while using stairs.</li> <li>- Ensure adequate lighting is available and functioning at staircases.</li> <li>- Ensure pathways are clear of obstructions and well-maintained.</li> <li>- Inspect footwear regularly for damage and replace as needed.</li> <li>- Display clear instructions on correct footwear at stair entry points.</li> <li>- Provide staff with appropriate footwear if necessary.</li> <li>- Conduct random checks to ensure compliance with footwear and awareness guidelines.</li> <li>- Develop and maintain an incident reporting system for stair-related hazards.</li> </ul>	2M
2. Ascending Stairs	Slips and trips, Carrying heavy loads	3H	<ul style="list-style-type: none"> <li>- Install sturdy handrails at accessible heights on both sides of the staircase.</li> <li>- Implement a 'one hand free' policy to encourage the use of handrails.</li> <li>- Stipulate maximum weight limits for individuals carrying loads.</li> <li>- Provide training on how to safely carry items without obstructing line of sight.</li> <li>- Ensure objects being carried are securely fastened.</li> <li>- Implement regular cleaning schedules for stairs to prevent accumulation of debris.</li> <li>- Encourage workers to report slippery surfaces immediately.</li> <li>- Employ anti-slip materials on stair treads.</li> <li>- Use signage to remind workers of safe carriage practices on stairs.</li> <li>- Allocate additional personnel for carrying heavy loads if necessary.</li> </ul>	1L
3. Descending Stairs	Loss of balance, Inattention	3H	<ul style="list-style-type: none"> <li>- Use high-visibility tape on the edge of steps to increase awareness of the edges.</li> <li>- Install clear and effective demarcation for the start and end of staircases.</li> <li>- Regularly remind workers to maintain focus while descending.</li> <li>- Conduct drills to practice safe descending techniques as part of training.</li> <li>- Place mirrors strategically at turns or landings for improved visibility.</li> <li>- Encourage a walking pace rather than running to prevent loss of balance.</li> <li>- Provide instant hazard reporting protocols via mobile apps for quick communication.</li> <li>- Ensure stairwell doors are fitted with slow-closing mechanisms to prevent injuries.</li> </ul>	2M
