4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Setting Up Scaffolding	Collapse of structure, Overloading	4H	<ul style="list-style-type: none"> - Use only certified and tested scaffolding materials. - Limit the number of workers on scaffolding at any time to reduce load. - Have a qualified person oversee the scaffolding assembly. - Follow manufacturer's guidelines for maximum loading capacity. - Train workers on safe loading practices. - Erect scaffolding on firm, level ground and secure as necessary. - Regularly inspect the scaffolding for signs of wear or damage. - Provide guardrails and toe boards to prevent falls. - Keep the scaffolding clear of equipment and debris. - Schedule regular inspections throughout the day to ensure stability. 	3H

Handling Tiles	Musculoskeletal disorders, Tile breakage	3H	<ul style="list-style-type: none"> - Provide manual handling training focused on ergonomic lifting techniques. - Use lifting aids or devices whenever possible to transport tiles. - Ensure work platforms are close to storage points to reduce handling distances. - Limit the weight of tile loads for manual handling. - Rotate tasks regularly to reduce repetitive strain on workers. - Store tiles securely to prevent them from falling or being knocked over. - Use appropriate PPE to protect against sharp edges of precut tiles. - Implement a buddy system for handling heavier tiles. 	2M
