Secure Vehicle	Vehicle roll, Unstable	3H	<ul style="list-style-type: none"> <li>- Engage the parking brake firmly.</li> <li>- Chock the wheel on the opposite side of where the tyre will be changed.</li> <li>- Select the appropriate jacking point as specified by the vehicle manufacturer.</li> <li>- Ensure the jack is suited to the vehicle's weight and height requirements.</li> <li>- Inspect the jack for any signs of damage or wear before use.</li> <li>- Place jack on stable, non-sloping ground.</li> <li>- Keep hands and feet clear of the jack and vehicle during lifting.</li> <li>- Do not exceed the load capacity of the jack.</li> <li>- Position a wheel chock behind the opposite wheel for additional security.</li> <li>- Maintain clear communication with any assistants.</li> </ul>	1L
