Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Identify Required Areas for Extension Cords	Tripping hazard, Overloading outlets	3H	<ul style="list-style-type: none"> - Survey the area to determine where extension cords are needed. - Use outlet load calculators to prevent overloading. - Ensure extension cords are not used as permanent wiring solutions. - Check outlet ratings against the appliance load ratings. - Use cable protectors or covers to minimize trip hazards. - Install additional power outlets if necessary to reduce cord use. - Ensure cords are placed out of high traffic areas. - Conduct regular inspections for early hazard detection. - Educate staff on the right and safe placement of cords. - Use the shortest possible lengths to minimize entanglement hazards. 	2M

Selection of Appropriate Extension Cords	Using incorrect cord rating, Cord damage	3H	<ul style="list-style-type: none"> - Select cords based on required length and amperage. - Purchase cords with appropriate insulation for the environment. - Regularly inspect cords for signs of wear or damage. - Consult with manufacturer specifications to ensure compatibility. - Label cords with their rating and application. - Provide training on the importance of using the correct ratings. - Maintain a log for cord inspections and replacement cycles. - Store unused cords in a dry, safe location. - Use only certified cords compliant with Australian standards. - Replace damaged cords immediately to avoid electrical hazards. 	2M
