### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage
Moderate	Medical-treatment injury; lost-time > 1 day	moderate delay	Minor breach; adverse client comment

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Transportation on Site	Container damage, Exposure to fumes	3H	<ul style="list-style-type: none"> <li>- Use carts or dollies with secondary containment for transport</li> <li>- Seal containers securely before transport</li> <li>- Train workers on manual handling techniques for hazardous materials</li> <li>- Ventilate areas where fumes may accumulate during transport</li> <li>- Limit movements to designated routes</li> <li>- Provide communication devices for quick reporting of incidents</li> <li>- Regular maintenance of transport equipment</li> <li>- Conduct prior risk assessment of transport routes</li> <li>- Enforce the use of respirators in areas with poor ventilation</li> <li>- Schedule transport during low traffic times</li> </ul>	2M
