Risk Rating & Required Action:	
<b>4A</b>	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
<b>3H</b>	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
<b>2M</b>	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
<b>1L</b>	Proceed, following standard operating procedures. Monitor and keep records.

  

Consequence Scale:			
Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
<b>Catastrophic</b>	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
<b>Major</b>	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage
<b>Moderate</b>	Medical-treatment injury; lost-time > 1 day	moderate delay	Minor breach; adverse client comment
<b>Minor</b>	First-aid only, no lost time	negligible delay	Isolated non-conformance

**Notes on Hierarchy of Controls:**  
Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Cross-contamination, Incomplete allergen information	3H	<ul style="list-style-type: none"> <li>- Train all staff on food allergen awareness and identification</li> <li>- Use separate preparation areas for allergen and non-allergen foods</li> <li>- Ensure all recipes are clearly labelled with allergen information</li> <li>- Regularly update allergen information as suppliers change ingredients</li> <li>- Keep a master allergen list for reference</li> <li>- Implement a thorough cleaning schedule for all preparation surfaces</li> <li>- Clearly mark designated allergen-free zones</li> <li>- Use colour-coded cutting boards and utensils</li> <li>- Communicate any changes in allergen protocols to staff immediately</li> <li>- Maintain a log of staff training sessions</li> </ul>	2M
2. Receiving Ingredients	Mislabeled ingredients, Damaged packaging	4H	<ul style="list-style-type: none"> <li>- Inspect all ingredient deliveries for proper allergen labelling</li> <li>- Train staff to identify and reject improperly labelled items</li> <li>- Check packaging for damage that may cause contamination</li> <li>- Use a tracking system to log all incoming ingredients</li> <li>- Require suppliers to provide updated allergen information</li> <li>- Store allergenic ingredients in clearly labelled, separate areas</li> <li>- Verify supplier certifications for allergen handling</li> <li>- Conduct periodic audits of supplier ingredient labels</li> <li>- Use protective equipment such as gloves during inspection</li> <li>- Establish a protocol to manage and report changes in suppliers</li> </ul>	2M
