Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Improper setup, Equipment fall	3H	<ul style="list-style-type: none"> - Conduct a toolbox talk to ensure all workers are aware of the tasks and hazards involved. - Verify that all operators have appropriate training for using the demolition saw. - Inspect the saw for any existing damage or faults before use. - Ensure that the workspace is clear of unnecessary materials and obstructions. - Confirm that all relevant permits and approvals have been obtained. - Set up barriers and warning signs to prevent unauthorized personnel from entering the work area. - Ensure that barricades and exclusion zones are properly established. - Acquire and set up suitable lighting to ensure clear visibility. - Confirm that ear muffs, gloves, goggles, and dust masks are accessible to all workers. - Perform a final walk-through to ensure readiness and verify control measures. 	2M

Tool Inspection	Mechanical failure, Electrical shock	3H	<ul style="list-style-type: none"> - Perform a visual inspection of the saw for damage or wear. - Check electrical cables and connections for any signs of damage. - Test the saw's functionality without a load to ensure operability. - Verify that all guards are securely fitted and operational. - Confirm that power sources are properly grounded. - Document inspection findings and address any issues before proceeding. - Ensure that a licensed electrician has checked electrical equipment found faulty. - Verify and calibrate emergency shutdown mechanisms. - Check that the blade is correctly fitted and secured. - Inspect PPE for any signs of damage before use. 	1L

Personal Protective Equipment (PPE)	Inhalation of dust, Eye injury	3H	<ul style="list-style-type: none"> - Ensure all workers are equipped with appropriate PPE: gloves, goggles, dust masks, earmuffs, and steel-capped boots. - Train workers on the correct use and fit of PPE. - Conduct regular checks to ensure PPE is worn at all times during operation. - Replace any damaged or worn PPE immediately. - Provide specific masks with higher filtration if cutting through hazardous materials. - Ensure availability of spare PPE on-site. - Conduct refresher training sessions on PPE use quarterly. - Post signage reinforcing the necessity of PPE in the work area. 	1L
