Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	lack of equipment, incomplete training	3H	<ul style="list-style-type: none"> - Conduct a pre-visit risk assessment to identify potential aggressive animal risks at the property. - Ensure all team members are adequately trained in animal handling and communication. - Verify that all necessary equipment, such as animal deterrents and first aid kits, are available and functional. - Review and rehearse emergency procedures in case of animal attack. - Confirm contact information for local animal control services. - Discuss the plan and roles during site visits in team meetings. - Ensure team members are wearing appropriate personal protective equipment (PPE). - Limit the number of personnel entering high-risk areas. - Establish a clear communication plan for any incident reporting. - Schedule property visits at a time when animals are least likely to be aggressive, where possible. 	2M

Arrival on Site	unexpected animal appearance, lack of visibility	3H	<ul style="list-style-type: none"> - Approach the property cautiously, observing any visible signs of aggressive animals. - Use binoculars and other aids to enhance visibility of hidden areas. - Knock or signal to alert any animals or property occupants of your presence. - Have an emergency plan ready in case of sudden animal appearance. - Monitor the surroundings continuously for any signs of danger. - Keep a safe distance from animals and assess their behaviour constantly. - Avoid making sudden movements or noise that could provoke animals. - Ensure that escape routes are clear and identified before proceeding. - Work in pairs or small groups when entering areas with potential risks. - Use mobile communication devices to stay in touch with team or support. 	2M

Property Inspection	animal attack, fall hazards	4A	<ul style="list-style-type: none"> - Maintain a safe distance from all animals unless properly trained and equipped for handling. - Identify and avoid areas where animals are kept or likely to roam freely. - Use barriers or enclosures to keep animals separated from the work area wherever possible. - Check for and remove any obstacles that could cause trips or falls. - Use appropriate ladders or support when inspecting elevated areas. - Have another team member in sight when conducting inspections near animal enclosures. - Specify certain locations as 'no-go' zones to avoid potential conflicts. - Always keep animals within visual contact if their presence is known. 	2M
