2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Attachment Installation	Crushing by equipment, Incorrect attachment use	4H	<ul style="list-style-type: none"> - Ensure that attachment installation is performed by trained personnel. - Use lifting devices to assist with heavy attachments to avoid manual handling risks. - Follow manufacturer's guidelines for attachment installation. - Perform a test run of the equipment with the new attachment installed. - Clearly mark installation areas with barriers to prevent unauthorised access. - Use lockout/tagout procedures to ensure de-energisation during installation. - Provide supervision during critical stages of the attachment process. - Deploy spotters to assist during the installation process. - Ensure attachments are compatible with the excavator type and model. - Regularly inspect attachment wear points for fatigue. 	2M
