Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. Substitute
3. Isolate
4. Engineering
5. Administrative
6. PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Remove Wheel	Fall of a vehicle, Manual handling injuries	3H	<ul style="list-style-type: none"> - Use vehicle hoist or jack stands as per manufacturer's instructions. - Engage vehicle brake and chock wheels not being worked on. - Ensure team follows correct posture while removing wheels to avoid strain. - Ensure proper use and maintenance of jacks and lifts. - Rotate tasks to avoid fatigue and strain. - Confirm all team members are trained in the use of lifting aids. - Use appropriate tools such as wheel dollies to help in removal. - Clear area around vehicle to prevent trips while handling the wheel. - Regularly monitor the condition of all lifting equipment used. - Provide guidance on ergonomics and lifting angles. 	2M
