### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. Substitute
3. Isolate
4. Engineering
5. Administrative
6. PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Secure Vehicle	Vehicle movement, Pinch points	4H	<ul style="list-style-type: none"> <li>- Engage the parking brake</li> <li>- Turn off the engine and remove the key</li> <li>- Use wheel chocks to prevent vehicle movement</li> <li>- Follow manufacturer instructions for securing vehicle</li> <li>- Ensure the vehicle is on a flat surface</li> <li>- Use appropriate jacking equipment if necessary</li> <li>- Provide sufficient clearance from other vehicles and structures</li> <li>- Advise others in the area that work is being conducted</li> <li>- Wear gloves to protect against pinch points</li> <li>- Be mindful of moving parts around the vehicle</li> </ul>	2M
