Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Selecting and Inspecting Bricks	Injury from dropped bricks, Brick defects causing accidents	3H	<ul style="list-style-type: none"> - Ensure bricks are stacked at a manageable height - Inspect bricks for any defects such as cracks or chips - Wear steel-toed boots to protect from dropped bricks - Provide gloves for handling heavy and rough materials - Instruct workers on proper lifting techniques for bricks - Use a buddy system to avoid solo handling - Regular communication of any newly found defects - Implement a regular quality check before use - Use mechanical lifting aids for inspecting higher stacks - Ensure all workers are aware of their surroundings while carrying bricks 	2M

Moving Bricks to Work Area	Strain from carrying heavy load, Collisions with other workers	4A	<ul style="list-style-type: none"> - Use trolleys or forklifts for transporting bricks when possible - Arrange work area to minimise long carry distances - Use a buddy system while transporting bricks - Provide rest periods to reduce fatigue - Clearly mark pathways for carrying materials safely - Limit individual brick load to a manageable weight - Train staff on proper load carrying techniques - Ensure clear communication amongst workers carrying bricks 	2M
