### Risk Rating & Required Action:

<b>4A</b>	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
<b>3H</b>	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
<b>2M</b>	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
<b>1L</b>	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
<b>Catastrophic</b>	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
<b>Major</b>	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

2. Initial Inspection	Unexpected animal behaviour, Contact with saliva	4H	<ul style="list-style-type: none"> <li>- Approach animals cautiously keeping a safe distance initially</li> <li>- Ensure inspection is conducted with proper protective barriers in place</li> <li>- Maintain constant awareness of animal behaviour</li> <li>- Use poles or remote tools for initial interaction</li> <li>- Have emergency medical support on standby</li> <li>- Record behaviour and physical condition of animal</li> <li>- If unfamiliar behaviour is observed, cease operation until further risk assessment</li> <li>- Use non-invasive techniques for inspection</li> <li>- Reduce time spent in close proximity with the animal</li> <li>- Ensure all personnel are clear on inspection protocol</li> </ul>	3H
