Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Filling Dispensers	Spillage, Product contamination	3M	<ul style="list-style-type: none"> - Train staff on proper filling techniques. - Use funnels and other tools to minimize spillage. - Ensure hands are washed before handling products. - Develop and enforce a strict filling procedure. - Use dispensers with easy-open lids to prevent spills. - Conduct regular checks of dispenser integrity and cleanliness. - Use closed containers for transporting products to dispensers. - Label all condiment containers clearly to avoid mix-ups. - Regularly sanitize the area where dispensers are filled. - Limit the amount of condiment containers opened at one time. 	2M
