### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Handling sharp tools, Slip and trip on wet surfaces	3H	<ul style="list-style-type: none"> <li>- Conduct a pre-start safety meeting covering possible risks and control measures.</li> <li>- Ensure all staff are wearing appropriate PPE such as steel-capped boots and gloves.</li> <li>- Conduct a walk-through to check for any wet or slippery surfaces and clean them immediately.</li> <li>- Ensure all tools are in good condition before use.</li> <li>- Limit the number of personnel in the immediate work area to essential staff only.</li> <li>- Place clear signage around wet areas.</li> <li>- Train staff on proper handling and maintenance of tools.</li> <li>- Use non-slip mats in areas prone to wetness.</li> <li>- Schedule regular maintenance of tools and equipment.</li> <li>- Designate a safety officer to monitor safe practices.</li> </ul>	2M

Initial Inspection	Contact with sharp edges, Ingestion or inhalation of dust	3H	<ul style="list-style-type: none"> <li>- Ensure all workers are wearing suitable gloves to prevent cuts.</li> <li>- Provide dust masks to all personnel in the area.</li> <li>- Use extraction systems to reduce airborne dust.</li> <li>- Clearly mark sharp-edged materials with high-visibility tape.</li> <li>- Ensure a first aid kit with bandages is accessible in case of minor injuries.</li> <li>- Regularly inspect and clean dust extraction systems.</li> <li>- Implement a buddy system to quickly address any injuries.</li> <li>- Provide training on inspection techniques to avoid hazards.</li> <li>- Remove any unnecessary materials that could cause obstruction.</li> <li>- Set up an emergency contact system for immediate assistance.</li> </ul>	2M
