### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	slip and trip, manual handling injuries	3H	<ul style="list-style-type: none"> <li>- Conduct a pre-work safety briefing with all workers.</li> <li>- Ensure work area is clean and free of obstructions before beginning work.</li> <li>- Ensure all team members are trained in proper manual handling techniques.</li> <li>- Provide appropriate personal protective equipment (PPE) such as gloves and non-slip boots.</li> <li>- Clearly mark all walkways and hazardous areas.</li> <li>- Use safety signs to alert workers to potential trip hazards.</li> <li>- Ensure first aid kits on site and accessible.</li> <li>- Regularly inspect work area for new hazards that may arise during work.</li> <li>- Limit load weights and use team lifting for heavier items.</li> <li>- Regular break times to avoid fatigue-related accidents.</li> </ul>	1L

Delivery of items	vehicle movement, uneven surfaces	4M	<ul style="list-style-type: none"> <li>- Only trained personnel should operate delivery vehicles.</li> <li>- Use spotters to guide vehicles in tight areas.</li> <li>- Provide traffic management training to all personnel involved.</li> <li>- Ensure delivery vehicles are fitted with reversing alarms and cameras.</li> <li>- Implement vehicle speed limits on site.</li> <li>- Use barriers or bollards to separate pedestrian pathways from vehicle access areas.</li> <li>- Ensure surfaces are level and free of debris where vehicles will be moving.</li> <li>- Trailers and vehicles should be properly maintained and regularly checked for faults.</li> <li>- Clearly signpost all traffic routes and crossings.</li> <li>- Restrict access to delivery areas to authorised personnel only.</li> </ul>	2M
