Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute**
- Isolate**
- Engineering**
- Administrative**
- PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Manual handling, Slippery surfaces	3H	- Conduct a site safety briefing for all personnel - Use appropriate personal protective equipment (PPE) such as gloves and safety boots - Check weather conditions and avoid working in wet weather - Clear the work area of any unnecessary materials or obstacles - Ensure proper training for all workers involved - Maintain clear communication among team members - Use warning signs to alert others of work being conducted - Plan the installation path to avoid slippery surfaces - Securely store tools and equipment to prevent trips and falls - Assign a supervisor to oversee the preparation process	2M

Sign Delivery	Traffic hazards, Incorrect lifting techniques	3H	- Use traffic management plans to minimize exposure to traffic - Unload signs using a forklift or crane where possible - Ensure delivery personnel are trained in manual handling techniques - Position delivery vehicles in designated areas away from traffic - Use barriers to separate the delivery zone from pedestrian areas - Conduct pre-delivery briefing on safe unloading procedures - Ensure delivery team wear high-visibility vests - Organise for assistance in lifting and moving heavy signs - Verify the condition of the delivered signs before unloading - Implement team lifting techniques for any manual handling required	2M

EMERGENCY RESPONSE – CALL 000 FOR EMERGENCIES

Ensure to have an Emergency Management Plan in place as well as adequate numbers of trained first aid staff with easy access to fully stocked first aid kits, rescue equipment, material safety data sheets, adequate access to emergency communication equipment and fire-fighting equipment suitable for all classes of fire and ignition sources.
