## Risk Rating &amp; Required Action:

<b>4A</b>	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
<b>3H</b>	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
<b>2M</b>	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
<b>1L</b>	Proceed, following standard operating procedures. Monitor and keep records.

## Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
<b>Catastrophic</b>	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
<b>Major</b>	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

## Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Unloading Furniture	Manual handling injuries, Crush injuries	4H	<ul style="list-style-type: none"> <li>- Use mechanical aids such as trolleys and forklifts when unloading</li> <li>- Provide training on proper lifting techniques to workers</li> <li>- Set up unloading in an area away from pedestrian traffic</li> <li>- Wear appropriate PPE, including gloves and steel-capped boots</li> <li>- Designate a spotter to assist drivers and workers during unloading</li> <li>- Inspect delivery vehicles for safe unloading features</li> <li>- Allocate sufficient personnel to assist with heavy items</li> <li>- Establish a clear communication protocol for team members</li> <li>- Mark and barricade the unloading zone clearly</li> <li>- Ensure the area is well-lit especially for late or early shifts</li> </ul>	2M
