Verify Isolation	Accidental re-energization, Contact with live wires	3L	<ul style="list-style-type: none"> <li>- Confirm the isolation procedure with all personnel involved.</li> <li>- Lock out the energy source with a lockout device after de-energization.</li> <li>- Tag the device with a visible warning tag indicating isolation.</li> <li>- Use a multimeter to confirm absence of voltage.</li> <li>- Appoint a competent person to oversee the isolation process.</li> <li>- Cross-check the isolation point with a second verifier.</li> <li>- Confirm that control switches are set to 'OFF' position.</li> <li>- Maintain a written log of the isolation process.</li> <li>- Ensure isolation points are not prone to accidental activation.</li> <li>- Implement a verification of isolation completion via a checklist.</li> </ul>	1L
