Preparation	Poor surface conditions, Insufficient lighting	3H	<ul style="list-style-type: none"> <li>- Inspect ladder and surrounding area for any debris or leaks</li> <li>- Ensure adequate lighting is installed over the work area</li> <li>- Have a colleague verify the conditions are suitable before proceeding</li> <li>- Install warning signs to alert others of ladder use</li> <li>- Use non-slip mats if surfaces are slippery watch for oil or liquid spills</li> <li>- Keep area clear of unnecessary equipment and personnel</li> <li>- Post a sign to indicate work in progress</li> <li>- Wear appropriate footwear with slip-resistant soles</li> <li>- Verify the ladder is not wobbling or unstable</li> <li>- Ensure all personnel are trained in ladder use and safety</li> </ul>	1L
