2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Selecting the Ladder	Incorrect ladder type, Damaged ladder	3H	<ul style="list-style-type: none"> - Verify the ladder type is suitable for the job and height required. - Inspect the ladder for signs of damage or wear before use. - Only use ladders that comply with Australian safety standards. - Avoid using makeshift ladders or ladder substitutes. - Ensure the ladder is rated for the load it will carry. - Train personnel in identifying ladder defects. - Record inspections of the ladder as per regulations. - Store ladders in a safe, dry place when not in use. - Use ladders made of non-conductive materials for electrical work. - Replace any ladder showing signs of damage immediately. 	1L
