Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Falls from height, Tripping hazards	3H	<ul style="list-style-type: none"> - Conduct a site inspection to identify potential tripping hazards and remove them. - Ensure that the ladder is suitable for the task and is in good condition. - Verify the work area is clear and stable before ladder setup. - Train workers on safe ladder usage and potential hazards. - Review the job plan with all workers involved. - Set up safety barriers around the work area. - Ensure workers are wearing appropriate footwear. - Use cones or tape to clearly delineate the work area. - Check weather conditions if working outdoors. - Keep the work area well-lit and organised. 	2M

Ladder Selection	Inappropriate ladder choice, Structural failure	3H	<ul style="list-style-type: none"> - Select a ladder that is appropriate for the task considering weight and height needed. - Ensure the ladder meets Australian standards. - Inspect the ladder for any visible damage or defects before use. - Establish a pre-use checklist for ladder inspection. - Train workers to identify ladder defects and report them. - Verify load rating is adequate for the job. - Make sure ladder length allows workers to reach task without overreaching. - Affix a tag on ladders indicating inspection status. - Avoid wooden ladders in environments where moisture may cause degradation. - Ensure all moving parts operate smoothly and are not loose. 	1L
3. Positioning the Ladder	Ladder instability, Imbalanced setup	4A	<ul style="list-style-type: none"> - Place ladder on a firm and level surface. - Secure the base and top of the ladder to prevent movement. - Ensure the ladder's locking mechanisms are secure before climbing. - Use a level to check ladder placement on uneven surfaces. - Tape or mark the appropriate angle for ladder placement (1:4 ratio). - Do not position ladders near doors or pathways unless barricaded. - Make sure the ladder extends at least 1 metre above the landing point. - Use ladder levellers if setting up on grass or soft ground. 	2M
