2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Use spotters or communication systems to monitor blind spots. Ensure all personnel are trained in emergency procedures. Check weather forecasts and postpone work if conditions worsen. Inspect ground stability before starting operations. Use mats or chocks to stabilize equipment on uneven surfaces. Maintain clear communication between driver and spotter. Limit speed during maneuvers in poor visibility. Use backup cameras or sensors if available. Conduct regular safety briefings. Stop work immediately if unsafe conditions develop. 	2M

Regularly inspect and maintain exclusion zone equipment. Provide training on the importance of exclusion zones. Use physical barriers where possible instead of just tape. Monitor zones continuously, even during breaks. Have a procedure for quickly clearing the zone in case of an emergency. 	1L

Follow manufacturer's instructions for setup and operation. Verify load capacity and weight distribution. Secure equipment against tipping or shifting. Use proper tie-down techniques for loads. Test brakes and safety features before full operation. Keep clear of moving parts and pinch points. Use fall protection when working from heights. Lock out/tag out equipment during maintenance. Communicate clearly with all team members. Use spotters for complex or high-risk setups. Document equipment checks and findings. Report any defects or issues immediately. Never exceed rated capacities. 	2M
