Risk Rating & Required Action:	
4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:
Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Lifting strains, Glass impact	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss delivery protocols. - Ensure all workers are trained in manual handling techniques. - Use mechanical aids to reduce manual lifting. - Assign sufficient personnel for unloading tasks. - Inspect personal protective equipment (PPE) for damage before use. - Designate a clear unloading area with no obstructions. - Have a first aid kit accessible in the unloading area. - Clearly communicate roles and responsibilities. - Limit manual handling weight limits for individuals. - Review all relevant safety procedures before commencing. 	2M
2. Unloading the Truck	Slips and trips, Glass breakage	4M	<ul style="list-style-type: none"> - Wear gloves and safety boots to protect against glass shards. - Inspect the ground surface for stability and tripping hazards. - Maintain clean and dry floors around the unloading area. - Establish a safe pathway from the truck to storage location. - Use safety signs to mark hazardous areas. - Operate under supervision or with a 'spotter'. - Restrict unauthorised personnel from the unloading vicinity. - Implement buddy system for additional safety support. - Ensure glass panels are stacked securely while unloading. - Quickly clean up any broken glass with appropriate tools. 	2M
3. Moving Glass Panels	Manual handling injuries, Panel falls	3H	<ul style="list-style-type: none"> - Use trolleys or glass handling equipment to move panels. - Restrict panel carrying to teams of two or more qualified handlers. - Avoid sharp turns and abrupt stops when moving panels. - Check that all mechanical aids are in good working order prior to use. - Decide routes with the least amount of obstructions. - Avoid walking backwards while moving glass panels. - Conduct periodic safety audits to ensure compliance. - Use soft, non-scratch tie-downs to secure glass. 	1L
