### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	slippery floors, clutter	3H	<ul style="list-style-type: none"> <li>- Conduct pre-inspection of the area to identify any visible hazards.</li> <li>- Ensure adequate lighting is in place to identify potential trip hazards.</li> <li>- Remove or clearly mark any temporary obstructions.</li> <li>- Clear gangways and emergency exits of any items that could impede evacuation.</li> <li>- Train staff on the identification of hazardous areas and avoidance measures.</li> <li>- Install anti-slip flooring where necessary, especially in high-traffic areas.</li> <li>- Ensure regular cleaning schedules are adhered to and documented in a log.</li> <li>- Place signs to warn of wet or recently cleaned floors.</li> <li>- Ensure compliance with company PPE requirements for footwear.</li> <li>- Perform regular audits to ensure all preventative measures are maintained.</li> </ul>	2M

Equipment Setup	unsecured cables, misplaced tools	3L	<ul style="list-style-type: none"> <li>- Use cable protectors to cover cords across walkways.</li> <li>- Ensure tools and equipment are stored in designated areas when not in use.</li> <li>- Regularly inspect equipment storage areas for compliance.</li> <li>- Instruct staff on proper cable management techniques.</li> <li>- Secure all loose cables and lines to avoid creating trip points.</li> <li>- Regular assessments by supervisors to ensure adherence to storage policies.</li> <li>- Highlight any residual risk areas with brightly coloured tape.</li> <li>- Establish a 'tool check-in/check-out' procedure to track equipment usage.</li> <li>- Conduct tool awareness training for all involved staff.</li> <li>- Establish visual reminders for proper cable and tool placement.</li> </ul>	1L
