Check while levels and top up as necessary. Ensure all vehicles and top up as necessary. Ensure all vehicles have a full emergency repair kit that includes spare parts. Maintain an emergency contact sheet inside every vehicle. Use only trained and licensed operators for plant operation. Install GPS systems for real-time monitoring and quick failure response. Have a logbook for each vehicle to track defects or maintenance needs. Remove faulty vehicles immediately from service to prevent usage until repair is confirmed.	2M

Utilise simulation-based training for practicing plant control mechanisms. Ensure all staff are familiar with emergency and evacuation procedures. Present a detailed site induction for new workers or those visiting the site. Include training on communication modalities while using equipment. Maintain a certified trainer to conduct all skill development sessions. Evaluate understanding via practical tests following the theoretical training.	1L




