Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Equipment Inspection	equipment malfunction, electrical hazards	4H	<ul style="list-style-type: none"> - Conduct visual and functional checks on all testing equipment before use. - Ensure all electrical connections are intact and properly insulated. - Calibrate instruments to manufacturer specifications. - Have a certified electrician inspect the setup if needed. - Maintain a log of all inspection activities with signatures of responsible personnel. - Isolate faulty equipment and tag it as 'Out of Service'. - Use insulated gloves when handling electrical components. - Ensure regular maintenance schedules are adhered to. - Keep water or liquids away from electrical devices. - Utilize surge protectors where necessary. 	2M
