### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. Substitute
3. Isolate
4. Engineering
5. Administrative
6. PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

2. Transport Auger to Site	Vehicle movement, Unsecured load	3H	<ul style="list-style-type: none"> <li>- Secure auger and related equipment properly in transport vehicle</li> <li>- Use warning signs and signals when moving the vehicle</li> <li>- Ensure drivers have a valid license and are experienced with larger vehicles</li> <li>- Perform a pre-start inspection of the vehicle</li> <li>- Avoid transporting loads during peak traffic times where possible</li> <li>- Use spotters when reversing or navigating tight spaces</li> <li>- Ensure proper load restraint techniques are used</li> <li>- Use GPS or maps to plan the safest route to the site</li> <li>- Conduct regular checks during transport to ensure loads have not shifted</li> <li>- Train staff in manual handling techniques specifically for loading and unloading</li> </ul>	2M
