### Risk Rating & Required Action:

<b>4A</b>	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
<b>3H</b>	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
<b>2M</b>	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
<b>1L</b>	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
<b>Catastrophic</b>	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
<b>Major</b>	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Isolation of Water Supply	unexpected water flow, inadequate isolation	4H	<ul style="list-style-type: none"> <li>- Use lockout/tagout procedures to isolate the water supply</li> <li>- Double check valve positions to ensure complete isolation</li> <li>- Use signage to indicate isolation</li> <li>- Train staff on the correct isolation procedures</li> <li>- Verify the effectiveness of isolation by checking downstream points for cessation of water flow</li> <li>- Appoint a responsible person to manage isolation locks and tags</li> <li>- Conduct verification tests before beginning maintenance</li> <li>- Consult system diagrams to identify all isolation points</li> <li>- Ensure isolation works are logged and communicated to relevant personnel</li> <li>- Keep an emergency procedure plan available in case of unintentional flow</li> </ul>	1L
3. Flushing the System	water pressure, splashing	3H	<ul style="list-style-type: none"> <li>- Use appropriate PPE, including goggles and gloves</li> <li>- Gradually increase water flow to manage pressure changes</li> <li>- Ensure all flushing points are secure before commencing</li> <li>- Monitor pressure gauges during the process</li> <li>- Communicate with team members about water pressures</li> <li>- Position team members to avoid splash areas</li> <li>- Have spill kits on hand to manage any unexpected overspill</li> <li>- Use signage to alert others of the flushing area and potential hazards</li> </ul>	2M
