### Risk Rating & Required Action:

<b>4A</b>	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
<b>3H</b>	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
<b>2M</b>	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
<b>1L</b>	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
<b>Catastrophic</b>	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
<b>Major</b>	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage
<b>Moderate</b>	Medical-treatment injury; lost-time > 1 day	moderate delay	Minor breach; adverse client comment
<b>Minor</b>	First-aid only, no lost time	negligible delay	Isolated non-conformance

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Slip hazards, Dust inhalation	3H	<ul style="list-style-type: none"> <li>- Conduct a pre-work safety briefing for all workers.</li> <li>- Ensure the work area is clean and free from obstacles that might cause trips or slips.</li> <li>- Use appropriate dust extraction and ventilation equipment.</li> <li>- Ensure all workers wear dust masks or respirators if required.</li> <li>- Conduct a site inspection to identify any additional hazards.</li> <li>- Provide training on emergency procedures.</li> <li>- Confirm all safety equipment is in working order.</li> <li>- Display warning signs in work area.</li> <li>- Ensure spill kits are available and personnel trained in their use.</li> <li>- Designate a safety officer for the duration of the project.</li> </ul>	2M

Mixing Compound	Chemical exposure, Back strain	3H	<ul style="list-style-type: none"> <li>- Use mechanical mixing equipment to minimise manual handling.</li> <li>- Ensure all mixers are equipped with dust extraction.</li> <li>- Wear appropriate PPE, including gloves and eye protection.</li> <li>- Follow manufacturer's instructions for mixing ratios carefully.</li> <li>- Keep material safety data sheets readily available.</li> <li>- Provide specific training on manual handling techniques to prevent back injuries.</li> <li>- Set up mixing stations to allow for ergonomic efficiency.</li> <li>- Limit the amount of compound mixed at one time to reduce risks.</li> <li>- Ensure good housekeeping in mixing areas to prevent slip hazards.</li> <li>- Implement a buddy system to assist with heavy lifting as needed.</li> </ul>	2M
