Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Water Connection	hose rupture, water leak	3H	<ul style="list-style-type: none"> - Use only hoses rated for pressure washer use. - Inspect hoses for wear or damage before connecting. - Securely connect hoses to appropriate water supply. - Ensure all connections are tightened properly to prevent leaks. - Use a filter to prevent debris from entering the system. - Avoid bending or twisting hoses during operation. - Regularly check hoses for leaks or bulges during use. - Position hoses to reduce trip hazards. - Follow manufacturer guidelines for maximum water pressure. - Use quick-connect fittings for secure hose connections. 	1L

Electrical Connection	electrical shock, equipment failure	4A	<ul style="list-style-type: none"> - Use residual current devices (RCDs) or ground fault circuit interrupters (GFCIs). - Ensure cords are rated for the current and are grounded. - Check cord and plug for signs of wear or damage. - Keep all electrical connections away from water. - Route cables to prevent trip hazards. - Never use equipment with frayed cords or exposed wires. - Ensure connections are moisture-proof. - Implement lockout procedures when connecting power. 	2M
