Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Switching Off Power	Electric shock, Arc flash	3H	<ul style="list-style-type: none"> - Locate and clear all personnel from the area - Use lock out/tag out procedures to isolate equipment - Test equipment to ensure power is off - Use appropriate PPE for electrical work - Ensure signage indicating de-energised equipment is clearly visible - Train workers in recognition of equipment states - Use appropriate tools to verify de-energisation - Have an emergency response plan in place - Regularly inspect and maintain lockout equipment - Maintain communication with all team members 	1L

Removing Old Fuse	Contact with live parts, Dropping fuse	3H	<ul style="list-style-type: none"> - Confirm de-energisation with a voltmeter - Use insulated tools designed for fuse removal - Wear rubber gloves to protect against accidental contact - Position hands safely to avoid dropping the fuse - Keep unused hand clear from live components - Maintain a safe and clear footing for balance - Work with a buddy to assist and watch for hazards - Use a flashlight if visibility is inadequate 	2M
