2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Site Preparation	Tripping hazards, Unsecured objects	3H	- Conduct a thorough site inspection to identify potential tripping hazards and unsecured objects. - Remove or secure any identified hazards before beginning operations. - Ensure adequate lighting is present throughout the site. - Use signage to alert workers to potential hazards. - Regularly maintain pathways to prevent the accumulation of debris. - Implement a 'clean as you go' policy to minimise tripping hazards. - Provide staff training on hazard awareness and response. - Assign a site supervisor to conduct regular safety checks. - Establish clear emergency pathways and ensure they are always unobstructed. - Ensure all workers wear appropriate PPE such as steel-toed boots.	2M

Vehicle Operation	Collision with structures, Reversing accidents	4A	- Implement a traffic management plan to ensure safe vehicle operations. - Use spotters to guide vehicles when reversing to prevent accidents. - Ensure all vehicles are fitted with reversing alarms and lights. - Conduct regular maintenance checks on vehicles to ensure safe operation. - Train workers in proper vehicle handling and operational procedures. - Enforce speed limits within the stockyard. - Clearly mark vehicle routes to avoid collisions with structures. - Prohibit the use of mobile phones while operating vehicles. - Schedule vehicle movements to minimise congestion. - Equip vehicles with GPS to track movements and ensure compliance with routes.	2M

Animal Handling	Animal bites, Trampling	4A	- Ensure all personnel are trained in animal handling and behaviour recognition. - Utilise animal restraints to safely handle and move animals. - Provide protective clothing and equipment such as gloves and boots. - Designate escape routes and emergency procedures for unexpected animal behaviour. - Limit the number of handlers to avoid crowding and confusion. - Keep non-essential personnel away from handling areas. - Inspect and maintain all barriers and gates regularly for integrity. - Use flags and boards to guide animals safely without physical contact.	2M
