2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Check all equipment for defects before use. Install barriers where there are changes in walking surface levels. Provide adequate lighting in all working areas. Assign a spotter to monitor and alert workers of any potential hazards. Utilise a buddy system for added awareness in complex activities. Regularly inspect and maintain floor surfaces to prevent slips and trips. 	1L
2. Tool Check	Defective tools, Inadequate PPE	3H	<ul style="list-style-type: none"> Conduct pre-operation checks on all tools for any noticeable defects. Ensure all tools are maintained according to manufacturer's specifications. Replace or remove defective tools from service immediately. Verify that all workers are equipped with adequate PPE, including gloves and helmets. Ensure workers are trained in the correct use of PPE. Introduce a tool tagging system to monitor maintenance schedules. Carry out regular internal audits of tool condition. Implement a reporting system for any identified tool defects. Ensure spare protective equipment is available onsite. Conduct toolbox talks focused on tool safety and PPE usage. 	2M

Provide space for workers to comfortably maneuver when using tools. Ensure clear access to emergency equipment and exits. 	1L
