Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Slippery surfaces, Inadequate lighting	3H	<ul style="list-style-type: none"> - Conduct a site inspection to identify and rectify slippery areas. - Ensure sufficient lighting is installed and operational before starting work. - Display appropriate signage for slippery areas. - Wear anti-slip footwear appropriate for the site conditions. - Use portable lighting if fixed lighting is inadequate. - Conduct work during daylight hours when possible to maximise visibility. - Train personnel in recognising and managing slip and trip hazards. - Ensure work areas are clean and unobstructed to prevent slips and trips. - Check and maintain all lighting equipment regularly. - Avoid work during adverse weather conditions if possible. 	2M
2. Bring Alternator to Work Area	Manual handling injuries, Obstructions	3H	<ul style="list-style-type: none"> - Perform a manual handling risk assessment for the task. - Use mechanical aids such as trolleys or forklifts to transport the alternator. - Clear pathway of obstructions before moving the alternator. - Train workers in proper manual handling techniques. - Ensure team lifting is available for heavy loads. - Implement a spotter system to guide movement of large objects. - Use appropriate PPE for handling materials. - Reassess work area for new hazards after moving. - Limit the number of personnel in the work area during equipment movement. - Maintain clear access routes throughout the work site. 	1L
3. Secure Alternator	Falling objects, Pinch points	3H	<ul style="list-style-type: none"> - Ensure the alternator is properly secured using clamps and straps. - Identify and mark pinch points with warning signs. - Use guards or barriers to separate workers from pinch points. - Train workers in recognising and avoiding pinch point hazards. - Inspect all securing equipment for integrity before use. - Equip workers with gloves and other PPE to protect from pinch points. - Maintain communication between team members during securing process. - Implement lockout/tagout procedures where applicable. 	2M
