Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Tool Segregation	Cross-contamination between clean and dirty tools, Injury from improper tool handling	3H	<ul style="list-style-type: none"> - Use separate containers for clean and dirty tools. - Label each container clearly. - Train workers on proper segregation techniques. - Regularly inspect containers for cleanliness. - Educate staff on the risks of cross-contamination. - Ensure workers use appropriate PPE. - Designate a specific area for tool segregation. - Implement a colour-coding system for easy identification. - Establish a monitoring routine for compliance. - Limit access to segregation areas to trained personnel. 	2M

Inspection of Tools	Injury from damaged tools, Exposure to infectious substances	3H	<ul style="list-style-type: none"> - Conduct a visual inspection of all tools before cleaning. - Implement a tool maintenance schedule. - Replace or repair damaged tools immediately. - Train staff on proper inspection techniques. - Use appropriate PPE during inspection. - Establish a checklist for inspection points. - Document all inspections and actions taken. - Limit inspection to trained personnel only. 	2M
