Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Securing Material	Instability of workpiece, Incorrect clamping	3H	<ul style="list-style-type: none"> - Use appropriate clamps to secure the workpiece - Check that material is not warped or damaged - Avoid holding workpiece by hand while cutting - Ensure the workpiece is stable and level on the table - Position body parts clear of cutting path - Double-check clamping mechanism for security - Use additional supports for longer materials - Communicate with team members about clamping standard procedures - Keep fingers clear from clamping area during setup - Periodically inspect clamping tools for wear and tear 	2M
