Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

1. **Eliminate**
2. **Substitute**
3. **Isolate**
4. **Engineering**
5. **Administrative**
6. **PPE**

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	Inadequate staff training, Failure to identify existing glass structures	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify all existing glass structures. - Ensure all workers are adequately trained in identifying and managing risks associated with glass structures. - Develop a detailed work plan highlighting the location of all glass structures. - Use markers or signs to clearly indicate glass structures. - Schedule a toolbox talk to discuss potential hazards. - Confirm that all workers understand the control measures before starting work. - Ensure that communication channels are clear and effective among all team members. - Review and update safety documentation as needed. - Consult with external experts if necessary. - Ensure adequate lighting to enhance visibility of transparent glass. 	2M

Site Setup	Inappropriate signage, Insufficient barriers	3H	<ul style="list-style-type: none"> - Install appropriate signage to warn of glass structures. - Use physical barriers to prevent access to glass structures. - Ensure barriers are visible and sturdy. - Allocate sufficient space between work areas and glass structures. - Use high visibility tape around glass. - Educate workers on the significance of barriers as part of site induction. - Check barriers regularly for stability. - Implement a buddy system to assist in setup monitoring. - Include site setup checks in daily safety walkarounds. - Ensure all workers know how to report issues immediately. 	3H

Tool Selection	Tools causing impact, Incorrect tools used	3H	<ul style="list-style-type: none"> - Choose tools that are less likely to cause vibrations or impacts on glass. - Inspect tools before use to ensure they are in good condition. - Train workers on using tools specifically around glass structures. - Use softer hand tools where possible instead of power tools. - Avoid tools that can create sudden impacts. - Implement a tool check system before and after work. - Ensure tools are fitted with vibration dampeners if necessary. - Provide a tool substitution list that minimises impact risks. 	2M
