- Substitute
- Isolate
- 4. Engineering
- 5. Administrative
- 6. PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Use GFCI (Ground Fault Circuit Interrupter) outlets. Restrict equipment operation to trained and authorised persons only. Postpone use of vulnerable equipment during severe weather. 	2M
