Accessing the Roof	fall from ladder, unstable access equipment	4H	<ul style="list-style-type: none"> <li>- Use ladders that are industrial grade and appropriate for the job</li> <li>- Secure the base and top of the ladder before climbing</li> <li>- Maintain three points of contact when climbing</li> <li>- Inspect the ladder and access equipment before use for any damage</li> <li>- Position the ladder on stable, level ground</li> <li>- Use a spotter when ascending and descending the ladder</li> <li>- Ensure roof access is planned and conducted in daylight where possible</li> <li>- Implement a buddy system for all ladder use</li> <li>- Clearly mark any equipment not to be used</li> <li>- Ensure ladders extend at least one metre above the landing point</li> </ul>	2M
