### Risk Rating & Required Action:

4A	Stop work. The risk is intolerable. Eliminate the hazard or redesign the activity before proceeding. A Safe Work Method Statement (SWMS) or higher-level authorisation is required.
3H	Review and approve additional controls before task starts. Senior supervisor sign-off needed.
2M	Ensure all nominated controls are in place and effective. Proceed with caution; monitor conditions.
1L	Proceed, following standard operating procedures. Monitor and keep records.

### Consequence Scale:

Consequence	People (injury/illness)	Project / Assets	Compliance / Reputation
Catastrophic	Fatality or permanent total disability	project shutdown	Significant regulator intervention; criminal prosecution
Major	Serious injury/illness (hospital > 5 days)	critical delay	Improvement notice; major media coverage

### Notes on Hierarchy of Controls:

Remember to apply controls in the preferred order shown by the coloured pyramid:

- Eliminate**
- Substitute
- Isolate
- Engineering
- Administrative
- PPE

Always document **why** a lower-order control is accepted if elimination or substitution is not reasonably practicable.

Preparation	glass breakage, sharp edges	3H	<ul style="list-style-type: none"> <li>- Ensure all personnel are trained in glass handling procedures.</li> <li>- Inspect glass for cracks or damages prior to use.</li> <li>- Wear appropriate PPE such as gloves and safety goggles.</li> <li>- Label and store glass safely on racks or pallets.</li> <li>- Designate a clear work area free from obstructions.</li> <li>- Keep first aid kits on hand, including supplies for cuts.</li> <li>- Use designated glass handling tools.</li> <li>- Limit work to well-lit areas to increase visibility.</li> <li>- Check all safety signage is in place and visible.</li> <li>- Report and document any incidents immediately.</li> </ul>	2M
2. Transporting Glass	dropping glass, back injury	3H	<ul style="list-style-type: none"> <li>- Use mechanical aids such as trolleys or glass suction grips for transport.</li> <li>- Do not carry glass alone; use a buddy system.</li> <li>- Ensure pathways are clear and dry before transport.</li> <li>- Train staff in safe lifting techniques.</li> <li>- Plan the route in advance to avoid unnecessary movement.</li> <li>- Schedule transport during low-traffic times.</li> <li>- Limit transport to the minimum number of people required.</li> <li>- Use clear communication signals between team members.</li> <li>- Avoid excessive stacking of glass pieces.</li> <li>- Regularly inspect transport equipment for defects.</li> </ul>	2M
