Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Dust and noise emission, tripping over equipment	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify hazards and implement necessary controls. - Ensure all personnel involved in the task are trained and competent in abrasive blasting operations. - Utilise dust extraction systems to minimise dust emission during abrasive blasting. - Provide appropriate personal protective equipment (PPE) such as respirators, hearing protection, and safety glasses or face shields to workers. - Clearly mark and barricade the work area to prevent unauthorised access. - Ensure electrical and air supply leads are organised to prevent tripping hazards, keeping them tidy and out of walkways. - Use noise barriers or enclosures around the blasting area to contain noise levels. - Implement a regular maintenance schedule for all equipment, checking hoses, connections, and components for integrity to ensure they operate efficiently and safely. - Monitor work area conditions, such as air quality and noise levels, to ensure they remain within safe limits throughout the job. - Inform and coordinate with neighbouring work areas about potential disruptions from dust and noise emissions. - Set up warning signs around the work area to inform others of the abrasive blasting operation in progress. 	2M

Setting Up Equipment	Electric shock, trapped fingers in machinery	3H	<ul style="list-style-type: none"> - Use electrical equipment that is tested and tagged in accordance with AS/NZS 3760 standards to prevent electric shock. - Ensure all power tools and extension leads are free from damage, wear, or faulty insulation. - Limit the use of extension leads by positioning power outlets closer to the work zone, thus reducing the risk of electric shock. - Implement lockout and tag-out procedures when servicing or setting up equipment to ensure it cannot be energised unintentionally. - Ensure all moving parts on machinery are properly guarded to prevent trapped fingers. - Provide appropriate personal protective equipment (PPE) such as insulated gloves for handling electrical connections. - Use signage and floor marking to delineate safe zones for workers while equipment is being set up. - Conduct a pre-start check of all equipment to identify any potential hazards such as loose components or electrical faults. - Clearly communicate start-up and shutdown procedures to all workers involved in abrasive blasting. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
