ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Assessing Area	Falling from heights, objects falling onto persons below	4A	<ul style="list-style-type: none"> - Conduct a thorough risk assessment of the area prior to commencing work to identify potential hazards. - Ensure all workers involved are trained in working at heights and the specific use of pulleys. - Overhead warning signs should be placed in the vicinity to alert others to the risk of falling objects. - Establish a clear exclusion zone with barriers around the base area where falling objects could potentially land. - Inspect all pulleys, ropes, and equipment for wear and damage before use to prevent equipment failure. - Use safety harnesses and fall arrest systems when working at height as appropriate. - Secure loose tools and materials to prevent them from falling during operations. - Implement a buddy system where one worker monitors the operation from a safe distance to ensure compliance with safety procedures. - Utilise safety helmets and other personal protective equipment (PPE) to protect personnel from injuries due to falling objects. - Communicate clearly with all team members about the tasks being performed to ensure coordinated operations and awareness of potential hazards. - Schedule regular breaks to maintain focus and reduce the likelihood of fatigue-related incidents. 	2M

Selecting Appropriate Pulley	Risk of selecting inappropriate equipment, causing damage or injury	3H	<ul style="list-style-type: none"> - Assess the weight of the items to be lifted and ensure the pulley chosen can handle at least 1.5 times that weight. - Ensure that the pulley system is rated for the specific load requirements and adheres to Australian Standards. - Provide training sessions on selecting the right pulley system based on the type of shelving and items being accessed. - Clearly label or color-code available pulleys with their load capacities for easy identification by all workers. - Regularly inspect and maintain pulley systems to ensure they are in safe working condition. - Engage a certified engineer to verify the adequacy and safety of the selected pulley system for unusual loads. - Introduce a checking procedure that must be signed off by a supervisor whenever a pulley system is selected and used. - Keep record of all pulleys, along with their maintenance logs, to track usage and wear over time. - Establish a policy that prohibits the use of homemade or modified pulleys without proper certification. - Review and update procedures/formats for selecting appropriate pulleys periodically to incorporate any new best practices or technologies. - Implement a tagging system that indicates when a pulley was last inspected and its upcoming inspection due date. - Encourage open communication among staff to report and discuss any concerns related to pulley equipment selection and use. - Provide access to alternatives like powered lifting devices when pulleys are deemed unsuitable for a particular task. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
