Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Isolation of Equipment	Incorrect isolation, Unknown circuitry	4A	<ul style="list-style-type: none"> - Conduct a thorough site assessment to identify all relevant circuit connections and equipment before commencing isolation activities. - Obtain and review site-specific diagrams or schematics that clearly outline the circuits and equipment involved. - Use lockout-tagout (LOTO) procedures strictly as per organisational guidelines to ensure equipment is isolated from energy sources. - Ensure clear communication among all team members regarding which circuits and pieces of equipment are being isolated. - Verify the identification of the correct switchboard and associated components prior to starting any work. - Employ the use of insulated tools and personal protective equipment (PPE) when dealing with potentially live components. - Double-check and confirm de-energisation by testing the circuits with appropriately rated testing devices. - Implement and maintain an exclusion zone around the switchboard area to prevent unauthorised access. 	3H

Access Live Switchboard	Electric shock, Fire hazard		<ul style="list-style-type: none"> - Conduct a pre-task risk assessment to identify potential hazards and determine appropriate control measures. - Ensure all personnel are trained and competent in working with live electrical equipment. - Use insulated tools and wear insulating gloves specifically rated for the task at hand to prevent electric shock. - Implement a lockout/tagout (LOTO) procedure to ensure that the switchboard is not energised unintentionally during access. - Maintain a safe distance from exposed live parts and ensure barriers or covers are used where feasible. - Ensure emergency communication devices like mobile phones are readily available and functional. - Appoint a spotter or safety observer to monitor activities and provide immediate assistance in case of an emergency. - Use flame-retardant clothing to minimize injury in case of an arc flash or fire incident. - Install smoke detectors and have fire extinguishers rated for electrical fires nearby. - Conduct regular inspection and maintenance of the switchboard to ensure it meets current safety standards and is free from dust and debris. - Ensure proper ventilation to reduce the risk of overheating and fire. - Keep the area clear of any flammable materials and ensure adequate lighting is available to carry out work safely. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
