Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Electric shock, Fall from height	4A	<ul style="list-style-type: none"> - Ensure all workers are trained and competent in electrical safety and working at heights. - Conduct a pre-work risk assessment to identify potential hazards. - Isolate power by switching off the circuit breaker before starting any work on light fittings. - Use lockout/tagout procedures to ensure that the power supply remains off during the task. - Wear appropriate personal protective equipment, such as insulated gloves and non-slip footwear. - Implement a permit-to-work system for tasks that involve electrical components or elevated positions. - Use stable and secure ladders or mobile platforms to access light fittings, ensuring they are set up on a flat surface. - Maintain three points of contact when climbing ladders and use ladder safety devices where possible. - Avoid overreaching or leaning while on ladders; reposition the ladder for better access if needed. - Inspect tools and equipment before use to ensure they are in good condition and suitable for the task. - Use low voltage power tools or battery-operated equipment to minimise the risk of electric shock. - Assign a spotter or observer to monitor safety compliance during the work process. - Establish clear communication protocols among all team members, especially if any unforeseen incidents occur. 	2M
2. Ladder Placement	Fall from ladder, Struck by moving vehicles	3H	<ul style="list-style-type: none"> - Select a ladder that is suitable for the task and rated for the weight it will support. - Ensure the ladder is in good condition, free from damage, and all safety mechanisms are functioning correctly. - Position the ladder on stable, flat ground to prevent wobbling or tipping. - Place the ladder at the correct angle, typically 1:4 ratio, meaning 1 unit out for every 4 units up. - Secure the ladder at the base or top to prevent movement during use, especially if on unstable surfaces. - Ensure no overhead obstacles like power lines can be contacted when setting up or using the ladder. - Use barricades or signs to create a safe work zone around the base of the ladder to warn others nearby. - Ensure workers using the ladder maintain three points of contact at all times to reduce the risk of falls. - Limit the time spent working from a ladder to reduce fatigue and loss of concentration. - Provide a spotter if practical to stabilize the ladder and alert the worker of potential hazards. - Prohibit the use of the top rung of the ladder unless designed for standing. - Always face the ladder while ascending or descending to maintain control and balance. 	1L

Isolate Power Supply	Electric shock, Burn injuries	3H	<ul style="list-style-type: none"> - Conduct a pre-start safety briefing to ensure all workers are aware of the isolation procedures. - Verify and confirm that the correct circuit breaker has been identified for the light fittings being adjusted. - Use lockout/tagout devices on the circuit breaker to prevent accidental re-energisation during work. - Ensure all workers involved have applied their personal lockout or tagout device before commencing work. - Test the power supply with a non-contact voltage tester to ensure it is fully de-energised. - Clearly label the isolated circuit and communicate its status to all personnel in the area. - Keep a written record of the isolation process, including time, date, and personnel involved. - Use insulated tools and equipment when working near electrical components to reduce the risk of electrical shock. - Maintain a clear work area around the electrical panel to avoid trip hazards that could lead to accidental contact with live components. - Ensure that only qualified and trained personnel perform electrical isolation tasks. - Have an emergency response plan in place, including first aid measures for potential electric shock incidents. - Wear appropriate personal protective equipment (PPE), such as rubber gloves and protective footwear, when performing the isolation. - Display visible warning signs indicating "Electrical Work In Progress" to alert other workers. - Verify the absence of potential back-feed from external sources before beginning the work. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
