Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Clean up spills immediately using absorbent material. - Use signage and barriers to cordon off work areas where there is increased potential for slips or trips. - Implement a buddy system for handling heavy or awkward loads, ensuring two or more people share the load evenly to minimise strain on individuals. - Ensure that adequate breaks are scheduled to avoid fatigue and provide workers with sufficient recovery time in between lifting tasks. - Keep tools and equipment regularly inspected and well-maintained to reduce the risk of malfunction or equipment failure. - Encourage workers to report any potential hazards, near misses or incidents to their supervisor as soon as possible. - Conduct regular toolbox talks with workers on the importance of workplace health and safety, focusing on specific hazards present at the worksite. - Store materials and equipment appropriately, ensuring they are not obstructing walkways or creating additional slip or trip hazards. - Routinely review and update safety procedures and policies to ensure compliance with relevant Australian Workplace Health and Safety legislation and industry best practices. 	1L

			<ul style="list-style-type: none"> - Fit pressure relief devices to the air receiver to minimise the risk of over-pressurisation and subsequent injury due to an explosion or rapid release of compressed air. - Utilise suitable Personal Protective Equipment (PPE) for employees working in close proximity to the air receiver, including safety glasses, hearing protection, and protective clothing. - Establish exclusion zones around the air receiver during operation to limit access to authorised personnel only, thereby minimising the risk of accidental exposure to high-pressure air. - Implement safe lifting and manual handling practices when moving, positioning or securing the air receiver, to reduce the likelihood of injury to workers. - Clearly display warning signs and labels adjacent to the air receiver to alert employees of the potential risks involved in its operation and ensure they follow pre-determined safety procedures. - Develop and implement emergency response plans, including evacuation and first aid procedures, in case an incident involving the air receiver occurs. - Regularly review and update Safe Work Method Statements (SWMS) to include new hazards identified during ongoing risk assessments and any changes in the work environment. - Encourage open communication between employees, supervisors, and management regarding workplace health and safety concerns, so that potential issues can be addressed promptly and effectively. 	
3. Equipment Set-Up	Incorrect installation, Use of damaged components	2M	<ul style="list-style-type: none"> - Ensure that the installation is carried out according to the manufacturer's guidelines and relevant Australian standards, such as AS 1210 and AS 4343. This will help prevent incorrect installation and use of damaged components. - Conduct a thorough inspection of all components before installation to identify any signs of damage, wear or malfunction. Replace or repair all damaged parts prior to equipment set-up. - Provide proper training and instruction to workers involved in the equipment set-up process, ensuring they are competent and aware of all safety precautions related to air receiver systems. - Use appropriate lifting gear and techniques when positioning the air receiver, preventing accidental drops or mishandling during installation. - Install all pressure relief and control devices as specified by the manufacturer, ensuring they are properly calibrated and tested for correct functionality. - Ensure that the air receiver is properly secured and grounded to prevent movement or displacement during operation and maintenance activities. - Install and maintain appropriate safety signage and warning labels on the air receiver, alerting workers to potential hazards associated with its operation. - Routinely inspect and maintain all piping, fittings, valves, and connections for leaks, corrosion, or damage, repairing or replacing components as necessary to prevent inadvertent system failure. - Consult with a qualified engineer or technical specialist if modifications or alterations to the system are required, ensuring compliance with relevant standards and regulatory requirements. - Ensure that all workers operating or maintaining the air receiver are provided with suitable personal protective equipment (PPE), such as safety goggles, hearing protection, and gloves, to reduce the risk of injury. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
