Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Code Setting	Electric shock, eye injury from flying debris	2M	<ul style="list-style-type: none"> - Ensure all personnel involved in code setting are trained in electrical safety and proper tool handling techniques. - Use insulated tools to minimise the risk of electric shock when working with electronic key safes. - Disconnect power supply to the key safe before commencing any work, if applicable, to prevent electric shock. - Perform a risk assessment and implement lockout/tagout procedures where necessary to ensure the key safe is not accidentally energised. - Equip workers with personal protective equipment (PPE) such as safety goggles to protect eyes from flying debris or accidental exposure to electrical components. - Maintain a clean and organised work area to reduce the likelihood of accidents caused by tripping or stumbling over tools and other materials. - Clearly label and store all tools and materials safely when not in use to prevent them from becoming hazards. - Conduct regular equipment inspections and maintenance checks to ensure all electrical components and tools are in good working order. - Establish clear communication channels between team members to quickly address any potential hazards identified during the task. - Implement a buddy system so that there is always someone to assist in case of an emergency situation. - Have a fire extinguisher readily available in the work area and ensure all personnel are trained in its use. - Develop and rehearse emergency response plans with all team members, focusing on first aid measures for electric shock and eye injuries. - Review and continuously improve Safe Work Method Statements (SWMS) based on feedback and incident reports to enhance safety practices. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
